The Board hereby invites interested reputable Companies with good track record of performance and experience to bid for the following:

2. SCOPE OF SERVICE

3. CONDITIONS FOR ELIGIBILITY:

All bids must be accompanied with the Following:

- Evidence of company registration with Corporate Affairs Commission (CAC) and supporting documents (Forms CAC2 and CAC7);
- Evidence of Company Income Tax Clearance Certificate for the last three (3) years (2017, 2018 & 2019) valid till 31st Dec 2020.
- Evidence of current Pension Compliance Certificate valid till 31st December, 2020;
- Evidence of current NSITF Compliance Certificate valid till 31st December 2020;
- Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 30/4/2020, or valid certificate issued by BPP;
- Evidence of relevant DPR Permit valid till 31st December, 2020;
- Evidence of ITF Compliance Certificate valid till 31st December, 2020.
- Sworn affidavit disclosing whether or not any officer of the relevant committees of the Nigerian Content Development and Monitoring Board (NCDMB) or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- Company's Audited Accounts for the last three years (2017, 2018,2019);

x. Evidence of financial capacity to execute the project by submission of Reference Letter from a reputable commercial bank in Nigeria, including a willingness to provide credit facility for the execution of the project where necessary;

xi. Company Profile with list of key technical personnel of the company, the Curriculum Vitae of key staff to be deployed for the project, including copies of their academic qualifications and relevant professional certification.

xii. Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including letters of Awards, Valuation Certificates, Job Completion Certificates, pictures of the projects;

xiii. List of plants/equipment with proof of ownership or valid lease Agreement (where applicable)

xiv. For Joint Ventures/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Compliance Certificate, ITF Compliance Certificate, NSITF Compliance Certificate, IRR & Sworn Affidavit are compulsory for each JV partner)

xv. All documents for submission must be transmitted with a Covering/Forwarding Letter under the Company Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No) and e-mail address.

5. SUBMISSION OF TENDER DOCUMENTS

Prospective bidders are to submit bid for each of the Lot desired, two (2) hard copies each of the technical and financial bids with soft copy of financial bid only in MS Excel format, packaged separately in sealed envelopes and clearly marked as "Technical Bid" or "Financial Bid".
